## Child Welfare Licensure Inquiry Information

The steps toward opening a Child Placing Agency or Group Residential Facility are as follows:

- A. A "certificate of need" must be addressed and obtained prior to any application process being initiated. The "certificate of need" is obtain through the West Virginia Health Care Authority (HCA) and is a statement from them indicating that your proposed agency or facility will not duplicate services in West Virginia and that there is a need for the proposed services. The application and other relevant information regarding the certificate of need may be obtained at <u>http://www.hcawv.org</u>.
  - A Request for Information/Request for Application (RFI/RFA) may be issued by the Bureau for Children and Families (BCF), when a specific need for a group residential facility or other behavioral health services has been identified. When this occurs provider agencies do not need to obtain a certificate of need, when responding to the RFI/RFA. To check for issued RFI/RFA's go to <u>http://www.wvdhhr.org/bcf/</u>.
  - 2. To expand or change services offered by an agency, a new "certificate of need" would be required.
  - 3. For the criteria of a Summary Review, please review <u>WV Statute 49-2-</u> <u>124.</u>
- B. Once an application has been made to the West Virginia Health Care Authority, they will determine your "certificate of need" status and notify your agency, as well as the BCF Child Placing and Residential Child Care Licensing Unit.
- C. BCF Licensing Unit will notify Office of Health Facility Licensure and Certification (OHFLAC) of the approval. If the approval is for a Residential Child Care Facility, OHFLAC will make contact with the facility to begin a Life Safety Inspection.
- D. The regulations for licensure for Child Placing Agencies and Residential Child Care Facilities provide the requirements for licensure in West Virginia and can be obtained at <u>http://www.wvsos.com</u>

- E. The State Fire Marshal's Office must be contacted to conduct a Fire Safety Inspection of any existing building or new construction, for all Residential Child Care Facilities. They can be contacted at 304-558-2191.
- F. The Bureau for Public Health will need to be contacted to complete an Environmental Health Inspection, for all Residential Child Care Facilities. They can be contacted at 304-558-2971.
- G. When your agency receives your "certificate of need" or it is determined that a certificate of need is not necessary, and has obtained the inspections by the State Fire Marshal and Bureau for Public Health (for Residential Child Care Facilities), an application for either a Child Placing License (Foster Care, Adoption, Transitional Living, Community Re-entry) or a Group Residential License (Group Residential Treatment Facilities, Emergency Shelters, Maternity/Parenting Facilities, Outdoor Therapeutic Educational Facilities, Intermediate Care Facilities for the Intellectually Disabled or Developmentally Disabled, Psychiatric Residential Treatment Facilities, and Therapeutic Residential Schools) must be submitted to the Bureau for Children and Families Residential Child Care Licensing page or by calling the Children and Adult Services at 304-558-7980 and ask to speak to someone in the Child Placing and Residential Child Care Licensing Unit.
- H. BCF's Child Placing and Residential Child Care Licensing Unit will complete a remote or on-site licensing review of your facility or agency prior to opening and will issue an initial license for 6 months. Another review will be completed prior to the expiration of the initial license for a regular license. A regular license can be issued up to two years.
- You will need to obtain a license to provide behavioral health services for children pursuant to WV Code §27-17-3. This license will be deemed by the Office of Health Facility Licensure and Certification (OHFLAC), based upon licensure from the Bureau for Children and Families (BCF). A copy of your application packet for BCF Licensure will be forwarded to OHFLAC for review.

- J. Once a license is issued by the BFC Licensing Unit, a copy will be sent to OHFLAC from BCF Licensing Unit, so they can issue a Behavioral Health License to the agency/facility.
- K. If the agency or facility plans to serve children in the custody of the State, you will need to contact the Division of Grant and Contracts, under the Bureau or Children and Families. They can be contacted at 304-558-8562.
- L. Agencies or Facilities providing residential and/or behavioral health services to children in State's custody will need to contact the Bureau for Medical Services through their contracted entity, Molina, for information regarding provider enrollment with the West Virginia Medicaid Program. Information can be obtained through the Provider Services Enrollment Unit at 888-483-0793 or 304-348-3360. A copy of your BCF Residential Child Care License and Behavioral Health License from OHFLAC must be submitted in your enrollment packet. Address: Molina- PO Box 625, Charleston, WV 25322-0625
- M. Agencies or facilities providing residential and/or child placing services will need to set up a FACTS PLUS account prior to accepting placements. Information can be obtained at <u>https://www.wvfacts.org/factsplusnet/</u>
- N. <u>Medicaid payment will not be issued until official enrollment occurs.</u> <u>Agencies with multiple programs must enroll each program separately with</u> <u>Medicaid.</u>
- O. <u>Placements cannot be accepted until your agency or facility has obtained a</u> <u>Child Placing or Residential Child Care License from BCF, a Behavioral</u> <u>Health License from OHFLAC and your enrollment with WV Medicaid is</u> <u>complete and approved.</u>
