LOCHHRA EXECUTIVE SUMMARY August 2013

- For August 2013, WV WORKS cases statewide increased to 10,213, up 123 cases compared to July 2013's 10,090 cases.
- Adult WV WORKS cases statewide for August 2013 are 5,218, up 73 cases compared to July 2013's 5,145.
- Child-only cases statewide for August 2013 are 4,995, up 50 cases compared to July 2013's 4,945 cases.
- Total support service payments for August 2013 totaled \$786,374, down \$15,609 from July 2013's \$801,983.
- The number of adult cases receiving WV WORKS for less than 12 months data has not been provided by RAPIDS since February 2012, due to data program changes.
- From December 1, 2001 through August 31st, 2013, 2,899 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,725 customers requested an extension of benefits up to an additional 6-month period; 712 of which were approved (for a 41.3% approval rate).
