LOCHHRA EXECUTIVE SUMMARY December 2013

- For December 2013, WV WORKS cases statewide increased to 10,218, down 60 cases compared to November 2013's 10,278 cases.
- Adult WV WORKS cases statewide for December 2013 are 5,186, down 43 cases compared to November 2013's 5,229.
- Child-only cases statewide for December 2013 are 5,032, down 17 cases compared to November 2013's 5,049 cases.
- Total support service payments for December 2013 totaled \$864,520, down \$9,319 from November 2013's \$873,839.
- The number of adult cases receiving WV WORKS for less than 12 months data has not been provided by RAPIDS since February 2012, due to data program changes.
- From December 1, 2001 through December 31st, 2013, 2,950 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,748 customers requested an extension of benefits up to an additional 6-month period; 729 of which were approved (for a 41.7% approval rate).
