LOCHHRA EXECUTIVE SUMMARY December 2017

- For December 2017, WV WORKS cases statewide decreased to **7,094**, down **172** cases compared to November 2017's **7,266** cases.
- Adult WV WORKS cases statewide for December 2017 are **2,034**, down **118** cases compared to November 2017's **2,152** cases.
- Child-only cases statewide for December 2017 are **5,060**, down **54** case compared to November 2017's **5,114** cases.
- Total support service payments for December 2017 totaled **\$340,431**, down **\$39,440** from November 2017's **\$379,871**.
- From December 1st, 2001 through December 31st, 2017, 3,290 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,944 customers requested an extension of benefits up to an additional 6-month period; 833 of which were approved (for a 42.8% approval rate).
