#### LOCHHRA EXECUTIVE SUMMARY February 2022

- For February 2022, WV WORKS cases statewide decreased to **5,472**, down **36** cases compared to January 2022's **5,508** cases.
- Adult WV WORKS cases statewide for February 2022 are 1,376, down 15 cases compared to January 2022's 1,391 cases.
- Child-only cases statewide for February 2022 are 4,096, down 21 cases compared to January 2022's 4,117 cases.
- Total support service payments for February 2022 totaled **\$127,243**, up **\$488** from January 2022's **\$126,755**.

From December 1<sup>st</sup>, 2001, through February 28th, 2022, **3,535** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,060** customers requested an extension of benefits up to an additional 6-month period; **890** of which were approved (for a **43.2%** approval rate).
