LOCHHRA EXECUTIVE SUMMARY July 2012

- For July 2012, WV WORKS cases statewide increased to 10,468, down 87 cases compared to June 2012's 10,555 cases.
- Adult WV WORKS cases statewide for July 2012 are 5,493, down 96 cases compared to June's 5,589.
- Child-only cases statewide for July 2012 are 4,975, up 9 cases compared to June's 4,966 cases.
- Total support service payments for July 2012 totaled \$1,119,959 down \$198,347 from June's \$1,318,306.
- The number of adult cases receiving WV WORKS for less than 12 months data has not been provided by RAPIDS since the February 2012, due to data program changes.
- From December 1, 2001 through July 31, 2012, 2,690 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,638 customers requested an extension of benefits up to an additional 6-month period; 668 of which were approved (for a 40.8% approval rate).
