

LOCHHRA EXECUTIVE SUMMARY

July 2013

- For July 2013, WV WORKS cases statewide decreased to 10,090, up 65 cases compared to June 2013's 10,025 cases.
- Adult WV WORKS cases statewide for July 2013 are 5,145, up 84 cases compared to June 2013's 5,061.
- Child-only cases statewide for July 2013 are 4,945, down 19 cases compared to June 2013's 4,964 cases.
- Total support service payments for July 2013 totaled \$801,983, down \$5,097 from June 2013's \$807,080.
- The number of adult cases receiving WV WORKS for less than 12 months data has not been provided by RAPIDS since February 2012, due to data program changes.
- From December 1, 2001 through July 31st, 2013, 2,877 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,723 customers requested an extension of benefits up to an additional 6-month period; 709 of which were approved (for a 41.1% approval rate).

Characteristics of the Current WV WORKS Caseload

July 2013

- √ **4,945** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **74** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **71** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **1,812** Cases receiving Medicaid but not SNAP.
- √ **83** Cases receiving SNAP but adults not receiving Medicaid.
- √ **1,208** Adults receiving WV WORKS and are employed.
