LOCHHRA EXECUTIVE SUMMARY July 2018

- For July 2018, WV WORKS cases statewide increased to **6,665**, up **25** cases compared to June 2018's **6,640** cases.
- Adult WV WORKS cases statewide for July 2018 are **1,703**, down **14** cases compared to June 2018's **1,717** cases.
- Child-only cases statewide for July 2018 are **4,962**, up **39** cases compared to June 2018's **4,923** cases.
- Total support service payments for July 2018 totaled **\$251,025**, down **\$12,165** from June 2018's **\$263,190**.
- From December 1st, 2001 through July 31st, 2018, **3,331** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,964** customers requested an extension of benefits up to an additional 6-month period; **844** of which were approved (for a **43.0%** approval rate).
