July 2022

- For July 2022, WV WORKS cases statewide decreased to 5,200, down 60 cases compared to June 2022's 5,260 cases.
- Adult WV WORKS cases statewide for July 2022 are 1,216, down 25 cases compared to June 2022's 1,241 cases.
- Child-only cases statewide for July 2022 are 3,984, down 35 cases compared to June 2022's 4,019 cases.
- Total support service payments for July 2022 totaled \$148,263, up \$15,544 from June 2022's \$132,719.

From December 1st, 2001, through July 31st, 2022, **3,556** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,072** customers requested an extension of benefits up to an additional 6-month period; **893** of which were approved (for a **43.1%** approval rate).
