LOCHHRA EXECUTIVE SUMMARY May 2019

- For May 2019, WV WORKS cases statewide decreased to **6,428**, down **1** case compared to April 2019's **6,429** cases.
- Adult WV WORKS cases statewide for May 2019 are 1,499, up 22 cases compared to April 2019's 1,477 cases.
- Child-only cases statewide for May 2019 are **4,929**, down **23** cases compared to April 2019's **4,952** cases.
- Total support service payments for May 2019 totaled **\$291,929**, up **\$43,150** from April 2019's **\$248,779**.
- From December 1st, 2001 through May 31st, 2019, **3,370** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,981** customers requested an extension of benefits up to an additional 6-month period; **854** of which were approved (for a **43.1%** approval rate).
