LOCHHRA EXECUTIVE SUMMARY November 2020

- For November 2020, WV WORKS cases statewide decreased to **5,854, down 7** cases compared to October 2020's **5,861** cases.
- Adult WV WORKS cases statewide for November 2020 are **1,524**, up **57** cases compared to October 2020's **1,467** cases.
- Child-only cases statewide for November 2020 are 4,330, down 64 cases compared to October 2020's 4,394 cases.
- Total support service payments for November 2020 totaled \$108,266, down \$6,835 from October 2020's \$115,101.
- From December 1st, 2001 through November 30th, 2020, **3,445** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **2,021** customers requested an extension of benefits up to an additional 6-month period; **870** of which were approved (for a **43.0**% approval rate).
