LOCHHRA EXECUTIVE SUMMARY November 2021

- For November 2021, WV WORKS cases statewide decreased to 5,643, up 15 cases compared to October 2021's 5,628 cases.
- Adult WV WORKS cases statewide for November 2021 are 1,425, up 1 cases compared to October 2021's 1,424 cases.
- Child-only cases statewide for November 2021 are 4,218, up 14 cases compared to October 2021's 4,204 cases.
- Total support service payments for November 2021 totaled \$128,311, up \$6,578 from October 2021's \$121,733.

From December 1st, 2001, through November 30th, 2021, **3,518** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,054** customers requested an extension of benefits up to an additional 6-month period; **887** of which were approved (for a **43.1%** approval rate).

Of the 887 cases approved through November 2021 for extension, 622 were for 6 months, and 265 were for periods of 1-5 months.
