

LOCHHRA EXECUTIVE SUMMARY

October 2011

- For October 2011, WV WORKS cases statewide increased to 11,283, down 139 cases compared to September 2011's 11,422 cases.
- Adult WV WORKS cases statewide for October 2011 are 6,309, down 143 cases compared to September's 6,452.
- Child-only cases statewide for October 2011 are 4,974, up 4 cases compared to September's 4,970 cases.
- Total support service payments for October 2011 totaled \$1,187,792, up \$172,904 from September's \$1,014,888.
- The number of adult cases receiving WV WORKS for less than 12 months is 39.2% (2,545 out of 6,309 cases), which is down from September's 39.4% rate.
- From December 1, 2001 through October 31, 2011, 2,548 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,573 customers requested an extension of benefits up to an additional 6-month period; 624 of which were approved (for a 39.7% approval rate).

October 2011

- √ **4,974** Child-only cases ---- parents not in the home and children living with a relative, or parents in the home, are receiving Medicaid and are excluded from the WV WORKS payment.
- √ **27** Cases currently receiving WV WORKS and received TANF in another state before moving to West Virginia.
- √ **203** Cases where parents are excluded from the payment due to being convicted of a drug-related felony after August 22, 1996.
- √ **1,776** Cases receiving Medicaid but not SNAP.
- √ **50** Cases receiving SNAP but adults not receiving Medicaid.
- √ **1,515** Adults receiving WV WORKS and are employed.
