LOCHHRA EXECUTIVE SUMMARY October 2015

- For October 2015, WV WORKS cases statewide decreased to **7,788** down **8** cases compared to September 2015's **7,796** cases.
- Adult WV WORKS cases statewide for October 2015 are **2,942**, up **9** cases compared to September 2015's **2,933** cases.
- Child-only cases statewide for October 2015 are **4,846**, down **17** cases compared to September 2015's **4,863** cases.
- Total support service payments for October 2015 totaled \$355,733, up \$46,409 from September 2015's \$309,324.
- From December 1st, 2001 through October 31st, 2015, **3,125** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, **1,876** customers requested an extension of benefits up to an additional 6-month period; **794** of which were approved (for a **42.3%** approval rate).
