### LOCHHRA EXECUTIVE SUMMARY October 2017

- For October 2017, WV WORKS cases statewide increased to **7,365**, up **7** cases compared to September 2017's **7,358** cases.
- Adult WV WORKS cases statewide for October 2017 are **2,252**, down **47** cases compared to September 2017's **2,299** cases.
- Child-only cases statewide for October 2017 are **5,113**, up **54** case compared to September 2017's **5,059** cases.
- Total support service payments for October 2017 totaled **\$386,571**, up **\$21,106** from September 2017's **\$365,465**.
- From December 1<sup>st</sup>, 2001 through October 31<sup>st</sup>, 2017, 3,283 WV WORKS cases have closed due to the adult(s) reaching the 60-month limit. Of that amount, 1,942 customers requested an extension of benefits up to an additional 6-month period; 831 of which were approved (for a 42.8% approval rate).
