LOCHHRA EXECUTIVE SUMMARY September 2022

- For September 2022, WV WORKS cases statewide increased to 5,345, up 42 cases compared to August 2022's 5,303 cases.
- Adult WV WORKS cases statewide for September 2022 are 1,330, up 47 cases compared to August 2022's 1,283 cases.
- Child-only cases statewide for September 2022 are 4,015, down 5 cases compared to August 2022's 4,020 cases.
- Total support service payments for September 2022 totaled \$198,536, down \$8,410 from August 2022's \$206,946.

From December 1st, 2001, through September 30th, 2022, **3,562** WV WORKS cases have closed due to the adult(s) reaching the 60-month limit of that amount, **2,073** customers requested an extension of benefits up to an additional 6-month period; **893** of which were approved (for a **43.1%** approval rate).
