- Thank you!

- Patient has terminal cancer
- As always, I evaluate and treat patients with their best interest in mind. I am aware of all the meds and issues the patient has. This is time consuming and has little value, but I understand the issue.

ASCVD w/o Statin

- Patient is on Atorvastatin 20 mg daily

HEP C

- Patient showed self resolution from lab work collected 3-22-22
- Although HCV antibody was positive, his viral load was not detected meaning he has cleared the virus.

Provider Comments



OPIOID AND BENZO

- Medication was prescribed short term for post operative pain. Pt has already discontinued.
- I have inherited this patient who is on multiple controlled substances. Lorazepam is rx by his neurologist and is in the process of being weaned.
- Patient recently established with me and am working to decrease.

NALOXONE

- Patient follows with another physician for routine care and pain meds.
- Naloxone has been prescribed.

HEP C

- Patient did not show up as scheduled.
- Patient was approved for the treatment but has been in jail the last few months. After his release he needed further lab work and would not answer or show up. I am always looking for patients who need treated.

GERD

- Controlled and Tagamet bid and PPI
